Dear Secretary Vilsack, Under Secretary Bonnie and Chief Tidwell:


The United States Forest Service (USFS) recently announced that it may try to block the renewal of two federal mining leases for Twin Metals Minnesota in northeast Minnesota and prevent all future mining opportunities in the Rainy River Watershed moving forward. This is despite the USFS' previous support for these lease renewals in 1989 and 2004 when the agency stated that the leases had no adverse environmental impacts.

To make its decision, the USFS is conducting a 30-day public input period from June 20 to July 20, 2016, culminating with a public comment hearing on July 13 in Duluth, Minnesota. Rather than follow the formal and well-established environmental review process for mining projects set forth under the National Environmental Policy Act (NEPA), the USFS has made the unprecedented and biased decision to potentially halt these projects before they can even begin. Environmental aspects of projects should be studied under the thorough, multi-agency, science-based Environmental Impact Statement (EIS) process that is required by NEPA **after** a specific mining project is proposed, according to the formal process. It is not appropriate to address the USFS' speculative and hypothetical environmental concerns under the normally routine federal mineral lease renewal process.

Additionally, the public comment hearing on July 13 is scheduled for a time and location that is inconvenient for many of the primary stakeholders – people who live and work on the Iron Range. The current time and location will prevent those most affected by these proceedings from having their voices on this important matter be heard. The USFS is denying them equal and adequate input in this debate.

That said, we are writing to you in hopes that you'll encourage the USFS to hold a public comment and listening session in the Iron Range. For those who live and work on the Range, their economy, livelihoods and community depend on this.
